




# Fantasy author Sir Terry Pratchett dies at 66




English fantasy and comedy author Sir Terry Pratchett died on March 12, 2015 at the age of 66 from Alzheimer's Disease. Pratchett was the best-selling English author of the 1990s, selling over 85 million copies in 37 languages. He authored the widely successful Discworld series, publishing on average two books a year since his first Discworld book, *The Color of Magic*, in 1983. His Discworld series told the story of a flat world situated on the backs of four giant elephants perched on top of an even larger sea turtle, swimming through space. Pratchett began the series in 1983 to "have fun with some of the clichés," making much of his work humorous or satiric. The Discworld series contains forty installments, with a forty-first scheduled to release in late 2015.


Pratchett suffered from a type of Alzheimer's which affected him only physically, allowing him to continue to write until his death, publishing 22 books and collections since his diagnosis in 2007. His later work included his first non-Discworld book since 1996, the critically acclaimed Nation. As an alternate history beginning after a devastating plague in the 1860s destroys the societal order, Nation won the Michael L. Printz Award in 2009. Media Specialist Mrs. Martha Spear said of Pratchett's work in Nation, "[Pratchett] was a master of the study of different cultures and how things can be turned upside down in a minute." Pratchett received a knighthood in 2009 for "services to literature." He comedically commented on his knighthood saying, "I suspect the 'services to literature' consisted of refraining to write any." His character and wit in his writing earned him many awards and drew millions of fans of all ages. Several fan conventions for the Discworld series have been organized since 1996, and international signing tours often followed book releases.


Pratchett announced his diagnosis with a rare form of early-onset Alzheimer's in 2007, describing it as an "embuggerance." In his later years, Pratchett heavily supported Alzheimer's research, donating \$1,000,000 toward the cause. Despite publicly saying he wished to die from assisted suicide, his death was from natural causes. After his death, his longtime assistant Rob Wilkins posted three final messages on his Twitter account, reading, "AT LAST SIR TERRY, WE MUST WALK TOGETHER," "Terry took Death's arm and followed him through the doors and onto the black desert under the endless night," and "The End." The tweets were a reference to the way the character of Death spoke in Pratchett's works. He is survived by his wife Lyn and their daughter Rhianna Pratchett, a games journalist and author.

Sir Terry Pratchett made meaningful contributions to the genres of fantasy and comedy writing. Larry Finlay of Transworld Publishers, Pratchett's publisher, in a statement said, "In over 70 books, Terry enriched the planet like few before him. As all who read him know, Discworld was his vehicle to satirize this world: he did so brilliantly, with great skill, enormous humour and constant invention." Pratchett's work will continue to influence the world far into the future. His life was a remarkable one, remaining active and sharp even as his "embuggerance" slowed him down. He will serve as a shining example of what the fantasy genre can be for decades to come.









# Germanwings plane crashes, investigation ongoing

A Germanwings plane crashed into the Swiss Alps on March 24. The plane was carrying 150 passengers, none of whom survived. So far, all evidence as to why the plane crashed points to the co-pilot, Andreas Lubitz.

After investigating Lubitz, it was found by investigators that he was severely depressed and was on medication. Investigators also found a document hidden in his apartment declaring that he was mentally unfit to work. One of two black box recorders were recovered from the plane. The box revealed how far the plane dropped from its cruising altitude along with a voice recording of the cockpit; this recording was leaked by a German newspaper.

The actual recording is not available to the public, but in the transcript, one can hear the other pilot banging on the locked door, telling Lubitz to open it. However, Lubitz stayed silent the whole time, as specified in the transcript. In a recent interview with Lubitz's exgirlfriend, she told reporters that Lubitz had been planning this crash, so the whole world would "know his name." Yet other people, like his neighbors, said he was a quiet man who would not be capable of doing something so devastating.

There have been many peculiar incidents about this crash. A German soccer team was scheduled to be on the flight, but they had switched right before it took off. Many of the players released statements to their fans, saying they were safe and praying for the victims.

Another odd occurrence was that on the crash site, the investigators found a SIM card from a phone of someone on the plane. On the card was a video of the last few seconds before the plane crashed. The video is low quality and no individuals can be identified. The crew is still working on getting out all of the bodies to return them home. Once all of the bodies have been claimed, and the crew will start to search for the second black box, which

they believe to be buried deep underground due to the force of the crash.

The nature of this crash is tragic, and many airline companies are trying to put systems in place to prevent these tragedies, and so far only a few have been working.

# The War on Terror continues:

# American troops sent to fight ISIS

In early March, a recent poll that was conducted for the American public, made by Forbes, revealed that over half of the American population has begun to support the idea of potentially deploying troops to fight against ISIS influences in various Middle Eastern nations. According to an article by Niall McCarthy in Forbes, the reason behind the spike in people's recent support has reportedly been caused by citizens' beliefs that the implementation of air strikes alone will not suffice in ending ISIS forces from continuing terrorist acts. Nevertheless, Democrats and Republicans have remained divided on the subject, thus making them unable to come to any sort of viable compromise.


Recently, the rising power of extreme militant groups in the Middle East has become increasingly difficult to ignore. The controversy over this issue has created heightened debate between America's major political parties. The fight over what America should do as a nation to end ISIS' reign of terror has thus forced many vital political leaders to take military action into serious consideration. During an address to the nation that he delivered from the White House in September, President Barack Obama vowed to "degrade and ultimately destroy" ISIS. In the past few months, protests have begun to ensue across the nation to provoke Congress to take action. Many of these protests are motivated by religious activists in order to protect Assyrian Christians that have been displaced by ISIS invaders.

According to an article by Adam Chandler from *The Atlantic*, "An American-led coalition launched 17

airstrikes in Iraq...[on March 25]...hammering Islamic State positions in the northern city of Tikrit. President Barack Obama reportedly approved the U.S. strikes after a request from Iraqi Prime Minister Haider al-Abadi, on the condition that Iraqi government forces working closely with American troops assume primary command of the anti-ISIS operation." The approach of air strikes to defeat ISIS forces has killed more than 6,000 ally soldiers. However, more than 1,000 foreign fighters join ISIS monthly. The reason behind the gain in new recruits is due to propaganda that ISIS has been broadcasting, like the burning of a Jordanian pilot among other executions made public. These acts of violence are all part of an effort to create a Sharia law-based government in Iraq and Syria, controlled solely by the militant groups. Whether or not the citizens of these Middle Eastern nations affected by ISIS support the enforcement of the Sharia law or fear it, the act of terrorism needs to be dealt with immediately.

Though the world's leading governments have remained stagnant on the issue, citizens are taking action. On Twitter, many accounts that are affiliated with ISIS and other associated members have been actively propagating terrorism. Another method civilians have attempted in hopes to defeat ISIS is by essentially deconstructing the system and infiltrating the system by going undercover in order to discretely join the group.

In the meantime, the argument of sending soldiers continues to be discussed globally. It is necessary that an



understanding or solution to the issue will be constituted sometime in May. If not, the issue may expand to other nations and cause further destruction both morally, physically and politically.

# Detroit Youth Employment initiative to kick off this summer

This summer, the Silkman Foundation will be awarding \$500,000 in grants to two major organizations in the city of Detroit to support a city-wide youth employment initiative. This collaborative act, known as the Grow Detroit's Young Talent (GDYT) strategy, will allow Detroit's young adult population to participate in a variety of six-week summer job opportunities.

Through the GDYT initiative, a \$400,000 grant will be given to the nonprofit organization, City Connect Detroit. This grant will fund the nonprofit to administer the program, provide youth employment training and secure job placements, while also conducting basic worker evaluations. The second grant of \$100,000 will be going to the Philadelphia Youth Network, which was the first to bring Detroit a state-of-the-art online employment portal that was originally developed in Philadelphia.

The online portal, directed by City Connect, will allow perspective employees and employers to sign up for the Grow Detroit's Young Talent program and thus, through an algorithm, match up each individual young employee to a plethora of employers around the city. This is to ensure a better outcome of employees being matched to jobs that seem to be a right fit for them, both interest wise and financially. Through the program, employers will be able to teach young Detroit citizens the importance of work readiness training, as well as basic knowledge of payroll logic and smart financial ethics. Wages for each job depends

on age and program selection, but ranges primarily from \$7.50 to \$10 per hour. Through the program, youths are allowed to work up to 120 hours.

During the 2014 Mackinac Policy Conference, Mayor Mike Duggan proposed a goal during his 2015 term to find employment for 5,000 young adults between the ages of 14 and

24, in and around the city of Detroit. With that, he pledged that the city would pay half of the \$2,000 cost for the program on behalf of each of the 5,000 persons employed this summer.

In the summer and fall of 2014, the program placed 1,897 Detroit youths in paid work experiences. Thus far, only 1,040 positions remain in the program for this summer.

It seems that since Trainor was not "strong enough" to have an eating disorder, she chose to insult those sick with destructive diseases, instead of promoting a more positive acceptance of one's own body. This is unacceptable because her main listeners are teenagers who make up for 95 percent of those with serious eating disorders like bulimia and anorexia. Some may say that these lyrics could promote seeking help for their sickness, but Trainor fails to recognize that eating disorders are not a choice, but a

Not only does Trainor seem to not accept all women for their unique attributes, unless they look like her, she also depicts the idea that female bodies are here for men's pleasure. In the song, she says, "Boys like a little more booty to hold at night," stating that a woman's body only exists for men. She not only pursues anti-feminist ideas within "All About That Bass" but inside her new song,

"Dear Future Husband" as well. She croons, "I'll be the perfect wife, buying groceries, buy-buying what you need," reinforcing that women are here specifically to fulfill a man's needs. Throughout the music video, she is seen baking and cleaning in the kitchen.

Junior Hana Coon commented, "Clearly, the video was going for a mid-twentieth century vibe with the hair and the makeup and the seductive floor-scrubbing, but combined with the equally outdated lyrics, it gives a message that is far from empowering. Besides implying that a woman's place still is in the kitchen, it also goes further and suggests that a woman's body and sexuality

> should be considered rewards for husband if he is good to her that day, you know, like opening doors for her." Coon continued, "Women are not just sitting around and waiting to offer themselves to men who let them win an argument that day. This is an incredibly harmful message,

as it perpetuates this objectification of women that is still prominent today." Coon acknowledges that the message Trainor seems to portray is counterintuitive to what it might, at first listen, seem to be implying.

Trainor also speaks about a woman's supposedly inferior place in the world in her song, "Title." She recites, "You gotta treat me like a trophy, put me on the shelf," shamelessly asking, very clearly, to be displayed as if she were nothing more than a prize. Yet again, she sends the message that a woman's worth is defined by the male gender. In the song she also begs a man to "Give me that title," which implies that committed relationships are something that men grant to women, not something that men and women decide together.

Trainor needs to see that her ideas about a woman's place in the world are not what they should be. Trainor, as a popular artist, should acknowledge the influence she has on young listeners and seek to promote healthy attitudes concerning body image for all and messages of support for female empowerment in her music.

# 165-year-old congressman dies in Senate chambers

BREAKING NEWS: 165-year-old congressman Iam C. Redible, collapsed late last night while giving a speech attempting to repeal the Affordable Care Act, also known as Obamacare, for the 76th time.

Congressman Redible was first elected at age 18 in 1868, and served the great state of Texas ever since. Before being elected, Redible fought for the Confederacy in the Civil War, which explains why Texas then elected him three years after, as Redible had dubbed it, "the war of northern aggression." In Redible's 147-year term, he has witnessed many historical political changes take place, most of which he was on the wrong side of.

In 1877, Redible's first bill he introduced as a congressman was the infamous Jim Crow Laws, which kept African Americans from having full civil rights. He smartly used the 'three-fifths' compromise of the Constitution, saying, "If our founding fathers thought [explicit] were only three-fifths of a person, who are we to reinterpret that?"

In 1920, when women were granted the right to vote, Redible campaigned with anti women's suffrage as a key part of his platform, and still won by a landslide. In fact, Redible took home an unprecedented 95 percent of the female vote that year.

Thirty four years later, at the ripe young age of 104, Redible spearheaded an all night filibuster in an attempt to prevent the famous Brown v. Board of Education ruling from taking effect, in which he famously said, "History will reflect poorly on those against segregation in America." The filibuster failed, and once again, he was on the wrong side of history, but as evidenced by his next 61 years in congress, neither Redible nor the voters cared.

Fast forward to 2008, when one of Redible's many great grandsons, this one traced

back to be the lovechild of one of Redible's many slave-master affairs, Barack Obama, was elected as President. When Redible was told that he was related to President Obama, he could only say the word 'no' for the next three weeks. Coincidentally, this put Redible on the right side of history for a change; when asked if he would vote to repeal the Lilly Ledbetter Fair Pay Act of 2009, Redible uttered the only word he could at the time, 'no.'

Outside of the congressional chambers, Redible had a very close relationship with FOX News. # Watch your language: words do hurt

Conversation is a basic staple in our everyday lives. What one accomplishes during this exchange of thoughts and opinions, however, is based not only on what one says, but how one says it. Recently, individuals have used the words "gay," "retarded" and "raped" out of context in normal conversation at school, at home and in public. Society in the 21st century has adapted the standard, shared vocabulary to include these words, therefore desensitizing people to their true meaning.

Phrases containing these socially incorrect words are plentiful. Some include: "That's so gay," "I got raped by that test," and "You are so retarded." These are just a few of the common slurs people hear on a daily basis that use these three words which bear very serious connotations in an intentionally or unintentionally immature and insensitive manner. The way these words are perceived can range anywhere from a joke to an insult, even when used in a mature and appropriate context. At BHS, these words are used, according to a poll taken of a sample of the student body and staff, in a joking matter 70 percent of the time, as an insult or inappropriately 22 percent of the time, and in proper context only eight percent of the time. Senior Morgan Rebori said, "It really bothers me when I hear these words said at school, and I have tried many times to make people stop, but they just brush me off and say it's not that big of a deal." These words have a permanent stigma attached to them and are not only harsh, but harmful and hurtful to those whom these terms directly apply and to those at whom they are aimed.

Surveying the BHS staff and student body indicated some revealing statistics regarding this issue. A significant 97 percent understand the true meaning of the words gay, retarded and rape, while only a miniscule three percent do not. If this is true, then one would assume that these knowledgeable individuals would refrain from using these hateful words in a derogatory way, but that is not necessarily the case. The data regarding whether or not members of BHS hear demeaning words said at school showed that 100 percent of the individuals surveyed do hear these terms said here as either a joke, as an insult or in another inappropriate context. This indicates that even though the majority of individuals know the meaning of these words, they still choose to use them, regardless if they know its use to be offensive.

Freshman Emma Stahl said, "We, as a school, need to work together in order to prevent the use of these words in an inappropriate way. Whether it is calling someone out when they say these words, or you yourself stop saying them, something needs to change."

Vocalizing these terms in any out of context, derogatory way creates a lack of respect towards those who are victimized by even just hearing them. One who is mentally handicapped, homosexual or has experienced sexual assault gets demeaned and directly insulted when people say such things without even giving their use a second thought. There is no fairness for people whom these words directly affect or those who associate these words to themselves. In associating these words with a negative connotation, it turns being offensive and targeting people into the accepted norm, and that itself, is unacceptable.

As a society, people need to strive to not implement these words in any setting, even the most basic of conversation. The issue of these terms being a part of our everyday speech is more of a matter of how these terms are said, but it would be even more beneficial to not voice them at all. We need to create a culture of respect towards different types of people and the lives that are lived distinctly unique to ours, starting with our language. Language may seem like a basic right, but it is also the first step towards change. Special Education teacher Ms. Megan Colligan said, "Bringing awareness to this issue, and people being more cognizant of what they say, will be extremely helpful in the long term process of change."

Ceasing the use of these words in any inappropriate context will have a powerful impact and can be the action that gets the ball rolling towards positive change. First language, then media coverage, and then policy changes will create respect and protection for the people to whom these terms apply, and then hopefully, this seemingly progressive nation will begin making a more positive environment for all individuals, especially those who are directly affected by these terms. The world can then move towards equal rights for those who are often left behind or receive a lack of respect that all individuals deserve.

# The fatal flaw in the professional world

When another person's life or mental stability rests in the hands of an individual, it is vital that they can be trusted. In many professions, like being a pilot, there are very few buffers between innocent citizens and a potentially mentally ill person. At the Germanwings airline March 26, a co-pilot deliberately brought down a plane due to mental illnesses. Due to this, it should be obvious that the flaw of lacking psychological testing, in the professional world, needs to be addressed in order to prevent this lapse in knowledge/testing to hurt any more people.

Pilots are trusted with flying over 150 people overseas, and have the complete fate of all the passengers resting in their hands. On April 3, a Germanwings plane was deliberately crashed a little north of Nice, France by the co-pilot, and it was later revealed that he was mentally unstable. The airline did not know this, even though there were records that were found after the fact saying that he was severely depressed, and that his depression was not under control. While he had attended therapy, the airline did not have knowledge of this because of their failure to implement psychological testing or even look into the mental health history of their employees. The lack of such a vital test resulted in the death of 150 innocent lives.

Another profession that does not require psychological testing, but most definitely should, is teachers. Teachers, for students of all ages, are trusted to help shape the lives of children who are only in the beginning stages of developing their identity. At such a young age, kids can be easily influenced, and it is important that these influences are positive. School is where most of a child's time is spent, and if one of the people he or she regards as a mentor or important influence negatively affects the children put into that teacher's care, it can be potentially scarring.

One of the jobs that is most influential to another person's mental being, a therapist, does not require any sort of mental health testing. Therapists are supposed to help someone conquer personal emotional and mental issues, but if a therapist has serious ones themselves, they will be unable to effectively mend a person's psyche. Therapists sometimes have to help their patient learn to think in new and positive ways, but if the therapist is unstable and primarily negative, they could potentially take an adverse toll on their patients' mental health that is already suffering.

Requiring psychological testing has been thought of for most professions, yet, it has never been implemented since it does not guarantee that anything substantial is necessarily found. Even though being mentally tested will not mean that no incidents will occur, it will set off red flags for those who really should not be placed in a job requires a great amount of responsibility, and it may catch something that could be dealt with before any serious mishaps or endangerment takes place. Sophomore Jon Cher agrees, "I think if [professionals] are responsible for the lives of other people they should be tested...it can't hurt." Although testing may be expensive, this potential life-saving step is more beneficial in the long run.

It is vital that psychological testing is implemented for those professions whose actions directly affect the lives of the people with whom they are working. Too many lives have already been compromised because of the lack of mental health testing, and it is time for

Students find fun in the sun...and on the couch




# What to look forward during Spring



# Starbucks attempts to race together: CEO activist shut down by the public

Starbucks recently made efforts to have customers discuss the often avoided topic of race, but the company ended up creating controversy nationwide with their Race Together campaign initiative. Something as simple as writing #racetogether on drinks sold to customers at every Starbucks location in the U.S. beginning in March stirred up fuss amongst employees, customers and across all forms of social media.

This campaign even caught the attention of the famous satiric television series, *Saturday Night Live. SNL* featured a fake commercial that targeted the "disastrous" attempt Starbucks made to increase racial awareness in the U.S. The feature on SNL depicted the campaign as a complete failure as well as mocking Starbuck's effort to make a real difference. English and Diversity Council teacher Mrs. Cindy Henderson said, "They attempted to get [people] talking about a problem that has, unfortunately, been in our country for a very long time. Just starting that conversation is a very positive thing." Even though Starbucks received a plethora of negative critics, there are individuals who support and respect the company's attempt at progress. The company perceived this SNL feature as a negative attack on the #racetogether initiative, as well as being harmful to its reputation and progress.

For Americans who watch *SNL*, it altered much of the public's opinion on the idea of the Race Together campaign. The message received was that this CEO activism by Starbucks is not only unwelcomed, but should be negatively criticized as well. Some people agreed with the message portrayed by *SNL* and did not acknowledge the company's initial purpose behind the campaign.

Many individuals even showed their distaste towards the #racetogether movement on Twitter. For instance, a man named Jamil Smith tweeted, "The only folks happy about Starbucks baristas discussing race with customers are the suits who run it. Feel-

good liberalism at its worst." This is just an example of what the millions of hate tweets directed toward Starbucks and its #racetogether campaign were like. The backlash toward Starbucks became even too much for the senior executive, who temporarily deactivated his account to avoid the negative posts and commentary.

The opposing reactions ceased the writing of #racetogether on cups after just one week. Mrs. Henderson added, "There has to be a certain level of comfort achieved in order for people to have conversations dealing with such a touchy subject, especially due to fear of offending others." However, the year long Race Together campaign will continue other parts of its program. Additional continuous efforts include forum discussions and special sections in *USA Today*.

The CEO's activism, however, was commended by some because certain individuals argued that Starbucks is seeking to exert political influence in a refreshingly transparent way. The CEO of Starbucks is widely known as one of this generation's biggest CEO activists. His powerful status gives him the audience and resources needed to make steps forward. Many believe his motive for the Race Together program was a marketing scam or PR exercise while others think the reality behind the program is to use his power for the good of many. # The world of tomorrow: coming advancements in science

Today, it is hard to determine where America stands in the field of science because advancements are minor or only affect a small number of people. Besides a bigger iPhone, what gifts has science and technology brought to the world in the last couple of years? Where exactly is science going? Has any progress actually been made? While significant changes may not be evident to everybody just yet, the field of science will be accomplishing more major breakthroughs in just a matter of years.

The most significant of the things to come is the compact fusion reactor. The battle for a clean source of energy may soon come to an end, as Lockheed Martin, an American company specializing in aerospace, defense, security and advanced technology, is developing said reactor. As they aim to "restart the atomic age," they are researching and developing a device capable of producing energy from nuclear fusion. The greatest aspect of these fusion reactors is how small they are. Instead of occupying a building, it is only the size of a truck. Thomas McGuire, head of the Skunk Works Compact Fusion Project, said in a video explaining the project that, "The small [size] is the reason we can do this quickly. If somthing is small, you can build up momentum, you can develop it fast... we think we can get to a prototype in five years." McGuire added, "This isn't online by 2100, this is online by the time—I can't even retire after we finish this." Once the fusion reactor is completed, the world will have access to a truly clean source of energy. Mr. Scott Doty, a science teacher at BHS, said, "If we have one of this size now, how long until it gets to the size of a microwave? We would never have to worry about electricity again. If it's not too expensive you can make a small one [to power cars]. Why would you need a battery?" The fusion reactor opens up a wide range of possibilities and practical applications that could change the world.

Another amazing invention is the Argus II, a new retinal implant known as the bionic eye. While blindness has always seemed improbable, if not impossible, to cure altogether; recent scientific developments have made recovery achievable. The implant allows people

that have gone blind from retinitis pigmentosa, a genetic disorder, to see again. The implant allows patients to see patterns of light, which they will be able to better interpret through practice over time. The implant changed the life of Allen Zderad, a man from Minnesota who was able to see his wife for the first time in ten years. A similar implant, developed by Bionic Vision Australia, was given to a Hawaiian woman, and she regained partial vision. According to Dr. Gregg Kokame, from Honolulu, Hawaii, the patient will recover and be able to detect motion in two months as well as see up to nine colors.



# Head trauma continues to plague the NFL:

#### 24-year-old star retires early for personal safety

The football world was shocked, on May 2, 2012, by the devastating news of a Hall of Fame linebacker's sudden death. A few days later, it was concluded that this tragedy of Junior Seau was a result of suicide. Seau seemed incredibly happy to anyone in contact with him in his younger days, but near the end of his life, his family noticed that he was not acting like his normal self. About seven months after Seau's death, his family learned that the cause of his depression was Chronic Traumatic Encephalopathy (CTE), which is a brain disease due to a large amount of head-to-head collisions.

In December of that year, the Kansas City Chiefs linebacker, Jovan Belcher, brought more attention to the NFL's head trauma predicament. Belcher, who later was diagnosed with CTE, drove him and his girlfriend to the Chiefs' training facility, where he murdered his girlfriend, and then proceeded to take his own life at the young age of 25. This devastating incident was later proved to be caused by Belcher's CTE.

Even though most players in the NFL do not develop the disease, it is becoming a major concern for the organization. Seau undoubtedly encountered the head-to-head collisions needed to cause CTE in his 20 year NFL career, not including his years of youth and college football. Due to Belcher's young age, it is evident that it does not take a long time for a serious brain injury to develop, and damage can accumulate on the brain from as early as when youth football is played. Although it took the tragedies of Seau and Belcher to bring attention to this serious issue, CTE has been present for quite a while. CTE was associated most commonly with boxers, but it was only recognized as a possibility for football players in 2005. The Department of Veteran's Affairs brain respiratory program has newfound research that indicates the brain scans of 79 randomly selected deceased former NFL players, and of those examined, only three of them did not have CTE, leaving the other 76 with the diagnosis.

With all of the new information available for football players today, many people wonder why children grow up and still strive to play in the NFL knowing the dangers that may result because of the sport. Chicago Bears' safety Chris Conte said, "I'd rather have the experience of playing in the NFL and die 10 to 15 years earlier than not play in the NFL and have a long life." Now, it must


be taken into account that Conte is only 26 years old, and may not fully comprehend just how much can be accomplished in 10 years of life. Although it is very rare and special to play in the NFL, it leaves one pondering whether the experience is really worth taking away a huge part of one's life.

Due to all of this controversy surrounding head trauma, several new rule changes have been put in place. First, the kickoff was moved up to the 35-yardline from the 30, making touchbacks more common, which eliminated one of the most dangerous plays in football: the kickoff return. Additionally, there has been a huge increase in flags thrown for hits on a defenseless receiver, which is another play that leads to many injuries over the course of the season.


Several injuries caused the San Francisco 49ers fans to take a huge loss this offseason when potential Hall of Fame linebacker Patrick Willis unexpectedly retired. Fans of the team were counting on young linebacker Chris Borland to take his place because he had a very successful rookie season, leading the league in tackles. But, after a couple concussions in college and his rookie year, Borland weighed the pros and cons of playing in the NFL and decided to retire at age 24. This included him voluntarily returning his signing bonus to the team, which was not required, essentially costing him millions of dollars

This decision sparked plenty of debate within the sports world. It is speculated that the number of children playing youth football will decrease soon, slowly weakening the NFL. Parents around the country are worried about their children playing youth football, from celebrities like LeBron James encouraging his sons not to play football, to kids like the students in the Berkley School District. Sophomore quarterback Ross Herron said, "My dad really warned me about the dangers of football. He didn't tell me not to do it, but he made sure I knew the risks I was taking." This is a commonly shared perspective amongst parents of youth football players.

Football is a violent game that was destined to be modified from the start despite many fans' and players' denial. There are too many lawsuits, injuries and deaths for the NFL to possibly keep the game of football at the same level of competition over the upcoming decades.

A brain scan that shows a normal brain as opposed to a brain with Advanced CTE.





# Sampling laws regarding copyright cause problems for musicians

Sometimes when listening to a song on the radio or on Spotify, one might find themselves thinking that they have heard this hook or instrumental before, and they might be right. What that listener is hearing is regarded as sampling.

Recently, many artists, generally in the hip-hop or R&B genre, have struggled to release their work due to copyright laws regarding samples

The history of sampling is relatively short: it originated in the 1960s, when many popular artists would manipulate vinyl records to create new music. However, sampling did not gain attention until the mid-1970s when hip-hop artists began creating full songs and sets to

perform out of each other's pieces. Many times, rap artists like Sugar Hill Gang, De La Soul, Biz Markie and others would create full bodies of work around music that inspired them and for a while, they were able to do so successfully. However, most of the artists sampled wanted to be compensated for another musician using their work and then not being credited. After many court cases, it was decided that each sample used in an album must be cleared or authorized through the creator, but this does not always happen. Even today, some of the best producers in muisc right now like Kanye West, MF Doom, Pharrell and RZA all use samples, but many believe that sampling regulations will hurt future projects for these types of producers and other artists.

Recently, Robin Thicke and Mac Miller have been shot into the public eye due to using samples that were not cleared by the original artists. The 2014 hit single "Blurred Lines" by Robin Thicke featuring T.I. and Pharrell caught some serious backlash for using a sample from the song "Got to Give it Up," by the legendary Marvin Gaye. The case began when the same cord progression that was used in "Got to Give it Up" was emulated by Pharrell while creating the "Blurred Lines" instrumental. In an interview with TMZ in early 2013. Thicke was quoted saying that Marvin Gaye was a major inspiration for his music. That has recently changed since the Gaye family filed a law suit against Thicke and producer of the song, Pharrell Williams. The trial began Feb. 10, 2015 and quickly ended March 10, 2015 with the verdict of Thicke owing the family \$7.6 million out of the \$16.1 million profited off the single and Pharrell was off the hook due to the song not being his own. Many




Kanye West in the studio mixing songs with his equipment. West predominantlyworks with samples.

artists disagree with the court's recent decision. Questlove, a member of the Roots, believes that "Blurred Lines" not technically plagiarized. "It's the same chord progression. That still doesn't make it plagiarized. We all know it's a derivative. That's how Pharrell works. Everything that Pharrell produces is derivative of another song, but it's homage," Questlove said. Pharrell works in a way that incorporates others to music to build off and now after the recent legal issue many fans of the producer question whether his creative process will have to change to avoid legal issues. "I enjoy all music that works to incorporating another person's sound. The act of doing creating music around another's work should not be illegal. We live in the digital age, and at this point, these laws seem to be a bit dated due to the new musical technology that producers have," junior Maliq Johnson said.

During Jermain Cole's new album 2014 Forest Hills Drive in a song dubbed "Note to Self' Cole announces that if an artist puts their work out into the world, it is up for grabs for anyone to use.

The Pittsburgh rapper Mac Miller was also caught using a sample that was not cleared in his song "Therapy," on his 2014 mix-tape Faces. Miller is being sued for about \$150,000 by '70s funk band Aquarium Dream. The use of the sample from the band cannot be denied. If one listens to the song "Yesterday" by the band, the sample can clearly be heard. Miller claims to have reached out to the band and then continued to use the instrumental after he was unable to contact the group. "Without permission from the original artists another cannot put their music out, and I do not blame Miller for just going for it after being ignored," Johnson said. This is not the first run in with the legal system for Miller. Back in 2012 Miller was sued by Lord Finesse part of the rap group D.I.T.C for using a sample of their song "Hip 2 Da Game." The single Miller released was named "Koolaid and Frozen Pizza" and again the use of a sample is undeniable.

This topic of copyright is not going to go away easily. With great producers like Kanye West, RZA and Pharrell Williams, who primarily use samples to form beats around, there is bound to be some trouble ahead. In the near future, many artists will look to these laws and find some unjust rules regarding samples. But for now, musicians will struggle to create original or revamped pieces from any inspiration without facing consequences.



Top players such as defending champions Duke's Okafor and Justise Winslow, along with runner up Wisconsin's Frank Kaminsky and Sam Dekker, are also projected to be top picks in the draft. The draft lottery will take place on May 19 and will determine which teams have the top picks for the actual draft; the draft is set to take place on June 25.

Although much of the news regarding the NBA Draft is about seniors and juniors who have been waiting their full length college careers for this moment, it also includes many freshman players who also feel like they are ready to play in the big leagues. Freshman players like Emmanuel Mudiay from China, and guards Tyus Jones and Melo Trimble, are getting prepared for the draft as well. All three are projected to go in the first or early second round this year.

As the date approaches, players from all over the world will commit to the NBA Draft. From there, they will await their moment to hear commissioner Adam Silver announce their name, welcoming them to their new NBA team.


